## Girls Rock Institute 2010 STUDENT APPLICATION

Hi! Welcome to the Rock 'n' Roll Camp for Girls. Every class at the Rock Camp is designed to be fun, intensive, and a great way to learn how to play music, improve skills, write, and perform. Every class is taught by women with skills and experience teaching, playing and performing music. We welcome students of all experience levels and skill, **NO EXPERIENCE NECESSARY!**

**Please Note: October 1, 2010, the age for students, campers and interns will change.**

GIRLS ROCK INSTITUTE AND SUMMER CAMP will serve campers and students ages 8-17.

INTERNS must be age 15-17.

VOLUNTEERS must be age 18 and up.

### Our programs include:

#### Rock Block \$250/term, 4:30-6:30 Tuesday or Wednesday, ages 8-18

One hour of instrument instruction followed by an hour of band practice. Students learn a new instrument or improve their skills, form bands, write an original song and perform it at the end of term Showcase! No experience is necessary to participate. We have enough instruments for everybody, but bring your own guitar, bass, or keyboard if you wish. Sessions are 10 weeks long.

#### Hip Hop Elements \$250/term, Tuesdays or Wednesdays, ages 8-18

Hands up, who thinks Portland needs an all girl break crew!! Study and practice of MCing, DJing, break dancing, creating your own beats on a computer, and beat boxing. No experience is necessary to participate. Sessions are 10 weeks long and culminate in an end of term Showcase performance!

#### Rock Camp Studio \$250/term, Tuesdays or Wednesdays, ages 13-18

Take your band and musical talents to the next level. Over 10 weeks, form a band and write a song that you can both record and play at the Showcase. Also learn fundamentals behind what it takes to record a band and put out your own music. Prerequisites: at least one term of GRI or Summer Camp, intermediate level in your instrument.

#### Band Center \$20/hr practice space, \$30/hr band coaching, ages 8-18

Band coaches help your band write songs, problem solve, get over a dry spell, learn how to use a wide variety of equipment. and eventually may help you book shows, make merchandise, and record a demo. Or, lead your own practice at Rock Camp and use your equipment or ours.

#### Private Lessons \$30/hr or as determined by instructor, ages 6+

From beginner to advanced, we provide a referral service for one on one instruction in drums, guitar, bass, keys, vocals, DJing, and songwriting. Lessons available to girls and women of all ages.

## HOW TO SIGN UP

**NEW STUDENTS:** Completely fill out and send in the **GRI Student Application** (pages 4-5 of this document), the **Code of Conduct Agreement, Media Release, and Assumption of Risk forms** (page 6-8). In order to be complete, your application must include ALL of the items on the Application Checklist.

**RETURN STUDENTS:** If all of your information, including emergency contact, is the same, **Returning Rock Block students** may fill out the Rock Block Short Form that is available online or in the lobby at Rock Camp.

## TUITION PAYMENT

**Rock Block, Hip Hop Elements, and Rock Camp Studio:** A \$10 application fee payable toward your tuition is due with your application. Tuition is due on the first day of class, or can be paid half on the first day, and half in the 5<sup>th</sup> week.

**Band Center:** You will be billed at the beginning of each month, or by arrangement with your band coach.

**Private Lessons:** As we are only a referral service, all payment arrangements are made with the instructor.

The Rock 'n' Roll Camp for Girls is a 501(c)(3) non-profit organization. Any amount paid over the standard fee is greatly appreciated and will be considered a tax-deductible donation. Tax receipts are available upon request.

I understand that Camp Activities may pose risks of bodily injury due to the inherent nature of each activity. I fully understand the risks and dangers associated with participation in Camp Activities, that the risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in Camp Activities, or the condition in which the Camp Activities take place. I also fully understand that there may be other risks and social and economic losses either not known to me or readily foreseeable at this time, and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in Camp Activities and assume all risks and responsibilities surrounding my participation in these activities.

2. I agree and warrant that I will examine and inspect each Camp Activity in which I take part, and if I observe any conditions that I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Camp Activity and will refuse to take part in the Camp Activity until the condition has been corrected to my satisfaction.

3. I hereby RELEASE, discharge, and covenant not to sue the Camp, its administrators, directors, agents, officers, volunteers, successors, assigns, employees, sponsors, advertisers, and if applicable, owners and lessors of premises where Camp Activities may occur (each considered one of the Releasees herein), from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf makes a claim, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS at my own expense each of the Releasees from any claims, suits, or actions of any nature, including attorney fees and costs, which are in any way connected with participation in any and all Camp Activities.
